# **Minimum Qualifications**

A completed (or nearly completed) Ph.D. (or equivalent) with a strong focus on the theories, politics and practices of food security and food justice is required.

Background or experience working with community food initiatives or organizations preferred. Teaching experience at the university level preferred.

Normal duties related to the design and teaching of a university credit course, including preparation and delivery of course content; development, administration and marking of assignments, tests and exams; calculation and submission of grades; and holding regular office hours.
